Melissa Taylor: Entrepreneur, Wife, Swimmer, Mother, and Survivor.

This month we had the distinct pleasure of sitting down with Melissa Taylor, the owner and founder of Small Fish Big Fish Swim School. Melissa passionately told us the story of her creation of her swim school and the amazing journey she has gone through to become the successful business owner and cancer survivor that she is today.

In 2009, Melissa worked in sales for luxury vehicles. Once she gave birth to her second child and after the disaster of the Bernie Madeoff scandal, she found herself out of work with a family to help support. After a brief stint in the sales of private jets, Melissa decided to go back to her roots and do what she loved: swim.

Melissa describes the water as a freeing experience. The weight of the world is literally off of you when you're in the water. Melissa began swimming competitively when she was 5 and now seemed as good a time as any to go back to what she enjoyed. Melissa re-trained in water safety and began advertising to teach children to swim in their own backyards. In order to protect herself, Melissa attended a conference in San Diego to secure insurance.

After the conference, Melissa was inspired and decided that she could and should create her own school. Her private lessons had increased in popularity and after trying to rent an indoor pool, a school seemed like a much better idea. At her core, Melissa believed that swim lessons save lives.

After several months of negotiating and finding the perfect space, Melissa designed her space, created a design for custom paint and arranged for the pool to be installed. It took almost five months to open the space, but it was well worth the wait.

At the same time, Melissa learned that she had breast cancer and would need to undergo aggressive therapy in



order to survive. This would include multiple surgeries, chemotherapy and radiation therapy.

When Small Fish Big Fish officially opened in



2012, there were only 10 students. Small Fish Big Fish now teaches more than 629 children per week to swim. While battling for her life, the opportunity to swim and to love what she was building for her family was important.

When we asked about her competitors, Melissa said that it's her passion and vision that sets school apart. She has their mission statement ("To teach self confidence, discipline, and well being through the lifelong sport of swimming") printed on the wall of the school as well as on each instructor's shirt. She lives with her goal and she follows it. She wants to ensure that the children are developing, learning and progressing. Additionally, Melissa believes that having a good staff develops good kids and this will develop leaders.

Melissa feels that her passion is the key to her success as a woman in business. She strives to always do the right thing. This is something that she looks for when she hires as well. She believes that having good people will create good business.

She laughed when we discussed her outright confidence in any situation and said "fake it until you make it."

As far as Melissa's favorite aspect of teaching children to swim, she says that it makes her feel phenomenal. If she ever feels bad, then she gets in the water and feels great. For the children, swimming comes so naturally and Melissa loves to watch them succeed.

However, Melissa's journey was not always easy. Aside from her cancer that put a monkey wrench in her business plan, her ability to raise her children and a general roadblock in her life, Melissa faced initial adversity from the men during the planning and design phase of her swim school. The engineers and builders did not think that she could possibly be in charge. When she met with the health department, she felt that they all looked at her as this little blonde person who couldn't possibly know what she was doing. This all just inspired Melissa to prove them all wrong. She was creating something important and it would be done her way, without regard to what they thought.

With regard to Melissa's favorite part of being a woman in business, she says that she loves to see other women succeed. After so many years in a male-dominated industry, she loves to see how other women are succeeding, how other people are generating success in their swim schools, and she likes to learn from them so that she may improve her own business. She also notices how you can touch someone's life and touch on his or her emotions. Watching a child learn to swim, teaching an adult to swim or helping someone with cognitive or physical impairments succeed in the water is an emotional and transcendent experience.

Melissa knows that being a woman running a swim school has its advantages. First of all, she is a mother and she's often helping with the babies. Other parents can talk to her about their fears with regards to their children and their

concerns with the water. Additionally, as a cancer survivor, Melissa is an open book. She helped women by allowing them to feel what a cancerous tumor felt like. She feels that if she can help women to detect cancer early, then she saves a life and saves a child from growing up without a mother.

At Small Fish Big Fish, Melissa also works with a lot of special needs children and adults. Through her own survival and her own limitations through her cancer treatments, Melissa has a unique compassion for helping these special needs children and adults. She understands first hand what it feels like to have limitations and she celebrates the lack of gravity on these people in the pool. For some, this is the first success they have on their road to recovery or in some cases learning to overcome their own obstacles.

Melissa's favorite groups to swim with are the special needs kids and adults and the infants. She feels that the success with the infants is particularly special because this is a group that not everyone can teach and she can teach them and do it well. It also helps that she gets the opportunity to cuddle with the new babies and see their first reactions to swimming.

Small Fish Big Fish holds many events throughout the year. Melissa particularly loves the charity events because they are her opportunity to give back. Each year Small Fish Big Fish participates in the World's Largest Swim Lesson that breaks the annual Guinness record. Melissa realizes that her work saves lives, particularly in Florida where we are surrounded by water. As a cancer survivor, Melissa loves to use her story to bring awareness and help others to detect early and survive better. She loves to touch and influence lives.

Melissa advises other entrepreneurial women to trust their gut. It has certainly worked for Melissa. Not only is Small Fish Big Fish a success, but Melissa works with her husband of 16 years and one will often see her two children at the swim school as well. The family atmosphere is one of the reasons that families come to Small Fish Big Fish. Once you're in, you've become a part of the family.

We were truly inspired by Melissa's personal story through leaving a career to focus on family and finally realizing her dream. All throughout her awe-inspiring story, Melissa remains optimistic and happy. Not many people could discuss something as heart wrenching as cancer with a smile on her face. Yet, Melissa sheds no tears for herself. She's still here and she's fighting for others. She just believes in the good in the world and that has clearly made her both a survivor and a success.
