The new <u>Taxpayer Advocate Service's</u> <u>Tax Reform Changes website</u> shows you how the new tax law may change your future tax filings and helps you plan for these changes. Currently, the site addresses the most common 2017 <u>IRS Form 1040, U.S. Individual Income Tax Return</u> topics and whether the tax law changed.

The information is categorized two ways: Tax topic such as income or payments and line by line in order of the 2017 IRS Form 1040. In addition, it includes scenarios to describe how the new law may affect you.

There is also a direct link to the <u>Paycheck Checkup</u>, where you can find a calculator to help you determine the right amount of federal income tax withholding and whether you need to adjust your <u>Form W-4</u>, <u>Employee's Withholding Allowance Certificate</u>. **(132 words)**
