- Income slips (T4, T4A, T4AP, T4E, T4RSP, T4RIF, T4AOAS, T4PS, T3, T5, T5007, T5013, RC62) Stock option / benefit plan statements from employer
- Realized gain/loss report for all investments sold this year (You can request a copy from your financial advisor)

RENTAL INCOME

- O Revenue and expenses, including mortgage interest, property tax, repairs, insurance, utilities, condo fees

- O Details of any capital improvements (e.g. renovations, roof replacement, appliance purchases)
- O If bought or sold this year, provide purchase/sale agreement, statement of adjustments, reporting letter from lawyer and allocation of value between land and building

SELF-EMPLOYMENT INCOME

- Revenue for the year (on an accrual basis)
- O FIT or micro FIT renewable energy contract revenue and expenses including details of purchase and installation costs.
- O HST returns, if applicable, for the year
- O Confirm method of accounting for HST (regular or quick method)

- O Indicate if family member (other than child) resides with you or is dependent on you
- O Current year rent/property tax information if eligible for Ontario tax credits
